Request for Qualifications (RFQ) On-Call Land Management Services

INTRODUCTION

The Santa Clara Valley Habitat Agency (Habitat Agency) is seeking qualified firms or individuals (Service Providers) to provide a range of on-call land management services to support habitat conservation, enhancement and restoration efforts. Service Providers qualified to provide one or more of the services listed below are encouraged to submit a qualifications package. Service Providers will be evaluated and added to an on-call list on an ongoing basis while this solicitation is open. Since the Habitat Agency will be initiating several projects this year that require on-call project support, Service Providers are encouraged to submit qualifications packages early in the RFQ solicitation period to maximize exposure to hiring opportunities.

BACKGROUND

The Habitat Agency is a joint powers authority formed on April 26, 2013, by the County of Santa Clara, and the Cities of San José, Morgan Hill, and Gilroy to implement the Santa Clara Valley Habitat Plan (Habitat Plan). Over the remaining 40 years of the Habitat Plan permitting term, the Habitat Agency will build a Reserve System of protected land that will be approximately 50,000 acres in size and will comprise lands of significant ecological value throughout the County of Santa Clara. The land in the Reserve System will be managed by the Habitat Agency for conservation and enhancement of habitat values in perpetuity.

The Habitat Agency currently manages over 10,000 acres of Reserve System land and has an immediate need for land management support services. Service Providers will work primarily on Reserve System lands and under the direction of Habitat Agency staff. The ideal candidates should have the personnel, experience, materials, equipment and ability to provide **one or more** land management services on the following list:

- Ability to provide proof of \$1 million coverage each for commercial general liability, commercial auto, and worker's compensation insurance in compliance with the Habitat Agency and list the Habitat Agency as Additional Insured. If projects are on County of Santa Clara lands, County compliance will also be required.
- Ability to enter into the Habitat Agency's Standard Consultant Services Agreement (**Template Attachment A**)

GENERAL TERMS AND CONDITIONS

Selected individuals or firms will be required to execute a Consultant Services Agreement which contains indemnification language and insurance requirements.

THE RFQ EVALUATION PROCESS

Submittals will be evaluated on qualifications, experience, and rates. Service Providers may be invited to interview, and the Habitat Agency may request additional information following the submittal of qualifications. Selected Service Providers will be notified within four weeks of their qualification submittal package and receipt of any additional information deemed to be important by Habitat Agency staff to enable adequate review of the service providers' package. Selected individuals or firms will be placed on the on-call list as soon as the review of submitted qualifications package is complete and the firm is accepted. It is anticipated that the list will remain active for approximately five (5) years.

<u>SECTION 5.</u> <u>METHOD OF PAYMENT.</u>

Each month, CONSULTANT shall furnish to the AGENCY a statement of the work performed for compensation during the preceding month, indicating work performed by each staff member and hours worked per day. The statement also shall include a detailed record of the month's actual reimbursable expenditures, if any.

SECTION 6. INDEPENDENT CONTRACTOR.

It is understood and agreed that CONSULTANT, in the performance of the work and services agreed to be performed by CONSULTANT, shall act as and be an independent contractor and not an agent or employee of AGENCY.

SECTION 7. ASSIGNABILITY.

The parties agree that the expertise and experience of CONSULTANT are material considerations for this AGREEMENT. CONSULTANT shall not assign or transfer any interest in this AGREEMENT nor the performance of any of CONSULTANT's obligations hereunder, without the prior written consent of AGENCY, and any attempt by CONSULTANT to so assign this AGREEMENT or any rights, duties or obligations arising hereunder shall be void and of no effect.

SECTION 8. INDEMNIFICATION.

CONSULTANT shall defend, indemnify and hold harmless AGENCY, its officers, employees and agents against any claim, loss or liability arising out of or resulting in any way from work performed under this AGREEMENT due to the willful or negligent acts (active or passive) or omissions by CONSULTANT's officers, employees or agents. The acceptance of services and duties by AGENCY shall not operate as a waiver of such right of indemnification.

<u>SECTION 9</u>. <u>INSURANCE REQUIREMENTS</u>.

CONSULTANT agrees to have and maintain the policies set forth in EXHIBIT D, entitled "INSURANCE," which is attached and incorporated. All policies, endorsements, certificates and/or binders shall be subject to approval by the Agency as to form and

content. These requirements are subject to amendment or waiver if approved in writing by the Agency. CONSULTANT agrees to provide AGENCY with a copy of the policies, certificates and/or endorsements before work commences under this AGREEMENT.

<u>SECTION 10.</u> <u>NONDISCRIMINATION.</u>

CONSULTANT shall not discriminate, in any way, against any person on the basis of race, sex, color, age, religion, sexual orientation, actual or perceived gender identity, disability, ethnicity, or national origin, in connection with or related to the performance of this AGREEMENT.

SECTION 11. TERMINATION.

- A. Either party shall have the right to terminate this AGREEMENT, without cause, by giving not less than seven (7) days' written notice of termination.
- B. If CONSULTANT fails to perform any of its material obligations under this AGREEMENT, in addition to all other remedies provided by law, AGENCY may terminate this AGREEMENT immediately upon written notice.
- C. AGENCY's Executive Officer is empowered to terminate this AGREEMENT on behalf of AGENCY.
- D. In the event of termination, CONSULTANT shall deliver to AGENCY copies of all reports, documents, and other work performed by CONSULTANT under this AGREEMENT, and upon receipt thereof, AGENCY shall pay CONSULTANT for services performed and reimbursable expenses incurred to the date of termination.

SECTION 12. STANDARD OF PRACTICE.

CONSULTANT shall exercise the degree of care and skill ordinarily exercised by companies in the same business performing the same or similar services at the same time and in the same geographic area. CONSULTANT makes no warranty, either

expressed or implied, as to the Services, except that the Services were performed pursuant to the standard of practice described.

SECTION 13. GOVERNING LAW.

AGENCY and CONSULTANT agree that the law governing this AGREEMENT shall be that of the State of California.

SECTION 14. COMPLIANCE WITH LAWS.

CONSULTANT shall comply with all applicable laws, ordinances, codes and regulations of the federal, state and local governments.

SECTION 15. CONFIDENTIAL INFORMATION.

All data, documents, discussions or other information developed or received by or for CONSULTANT in performance of this AGREEMENT are confidential and not to be disclosed to any person except as authorized by AGENCY, or as required by law.

<u>SECTION 16.</u> <u>OWNERSHIP OF MATERIALS.</u>

All reports, documents or other materials developed or discovered by CONSULTANT or any other person engaged directly or indirectly by CONSULTANT to perform the services required hereunder shall be and remain the property of AGENCY without restriction or limitation upon their use. It is understood by both parties that materials will be subject to the Public Records Act.

SECTION 17. WAIVER.

CONSULTANT agrees that waiver by AGENCY of any breach or violation of any term or condition of this AGREEMENT shall not be deemed to be a waiver of any other term or condition contained herein or a waiver of any subsequent breach or violation of the same or any other term or condition. The acceptance by AGENCY of the performance of any work or services by CONSULTANT shall not be deemed to be a waiver of any term or condition of this AGREEMENT.

SECTION 18. CONSULTANT'S BOOKS AND RECORDS.

- A. CONSULTANT shall maintain any and all ledgers, books of account, invoices, vouchers, cancelled checks, and other records or documents evidencing or relating to charges for services, or expenditures and disbursements charged to AGENCY for a minimum period of three (3) years, or for any longer period required by law, from the date of final payment to CONSULTANT pursuant to this AGREEMENT.
- B. CONSULTANT shall maintain all documents and records which demonstrate performance under this AGREEMENT for a minimum period of three (3) years, or for any longer period required by law, from the date of termination or completion of this AGREEMENT.
- C. Any records or documents required to be maintained pursuant to this AGREEMENT shall be made available for inspection or audit at no cost to AGENCY, at any time during regular business hours, upon written request by the Executive Officer, Finance Officer, General Counsel, or a designated representative of any of these officers. Copies of such documents shall be provided to AGENCY for inspection. Unless an alternative is mutually agreed upon, the records shall be available at CONSULTANT's address indicated for receipt of notices in this AGREEMENT.
- D. If AGENCY has reason to believe that such records or documents may be lost or discarded due to dissolution, disbandment or termination of CONSULTANT's business, AGENCY may, by written request by any of the above-named officers, require that custody of the records be given to AGENCY. Access to such records and documents shall be granted to any party authorized by CONSULTANT, CONSULTANT's representatives, or CONSULTANT's successor-in-interest.

<u>SECTION 19. SPECIAL PROVISIONS.</u>

Special provisions, if any, to this AGREEMENT are specified in EXHIBIT E, entitled,

"SPECIAL PROVISIONS", attached and incorporated.

SECTION 20. NOTICES.

All notices and other communications required or permitted to be given under this

AGREEMENT shall be in writing and shall be personally served or mailed, postage

prepaid and return receipt requested, addressed to the respective parties as follows:

Notice shall be deemed effective on the date personally delivered or, if mailed, three (3)

SECTION 21. VENUE.

If either party to this AGREEMENT brings a lawsuit related to the AGREEMENT, the

parties agree that venue shall be exclusively vested in the state courts of the County of

Santa Clara, or if federal jurisdiction is appropriate, exclusively in the United States

District Court, Northern District of California, San Jose, California.

<u>SECTION 22.</u> <u>INTERPRETATION, PRIOR AGREEMENTS AND AMENDMENTS.</u>

This AGREEMENT, including all Exhibits attached, represents the entire understanding

of the parties as to those matters contained herein. In the event the terms specified in

any of the Exhibits attached conflict with any of the terms specified in the body of this

AGREEMENT, the terms specified in the body of this AGREEMENT shall control. No

prior oral or written understanding shall be of any force or effect with respect to those matters covered hereunder. This AGREEMENT may be modified only by a written amendment duly executed by the parties to this AGREEMENT.

EXHIBIT D

<u>INSURANCE</u>

CONSULTANT, at CONSULTANT's sole cost and expense, shall procure and maintain for the duration of this AGREEMENT insurance against claims for injuries to persons or damages to property which may arise from, or in connection with, the performance of the services hereunder by CONSULTANT, its agents, representatives, employees or subcontractors.

A. <u>Minimum Scope of Insurance</u>

Coverage shall be at least as broad as:

- 1. The coverage provided by Insurance Services Office Commercial General Liability coverage ("occurrence") Form Number CG 0001; and
- The coverage provided by Insurance Services Office Form Number CA 0001 covering Automobile Liability. Coverage shall be included for all owned, nonowned and hired automobiles; and
- 3. Workers' Compensation insurance as required by the California Labor Code and Employers Liability insurance; and
- 4. Professional Liability Errors & Omissions for all professional services.

There shall be no endorsement reducing the scope of coverage required above unless approved by the Agency Counsel.

B. Minimum Limits of Insurance

CONSULTANT shall maintain limits no less than:

- 1. Commercial General Liability: \$2,000,000 per occurrence for bodily injury, personal injury and property damage. If Commercial Liability Insurance or other form with a general aggregate limit is used, either the general aggregate limit shall apply separately to this project/location or the general aggregate limit shall be twice the required occurrence limit; and
- 2. Automobile Liability: \$2,000,000 combined single limit per accident for bodily injury and property damage; and
- 3. Workers' Compensation and Employers Liability: Workers' Compensation limits as required by the California Labor Code and Employers Liability limits of \$2,000,000 per accident; and

4. Professional Liability Errors & Omissions \$2,000,000 per occurrence/ aggregate limit.

C. <u>Deductibles and Self-Insured Retentions</u>

Any deductibles or self-insured retentions must be declared to, and approved by Agency Counsel. At the option of AGENCY, either: the insurer shall reduce or eliminate such deductibles or self-insured retentions as respects AGENCY, its officers, employees, agents and contractors; or CONSULTANT shall procure a bond guaranteeing payment of losses and related investigations, claim administration and defense expenses in an amount specified by the Agency Counsel.

D. Other Insurance Provisions

The policies are to contain, or be endorsed to contain, the following provisions:

- 1. Commercial General Liability and Automobile Liability Coverages
 - a. The Santa Clara Valley Habitat Agency, its officers, employees, and agents are to be covered as additional insureds as respects: Liability arising out of activities performed by or on behalf of, CONSULTANT; products and completed operations of CONSULTANT; premises owned, leased or used by CONSULTANT; and automobiles owned, leased, hired or borrowed by CONSULTANT. The coverage shall contain no special limitations on the scope of protection afforded to AENCY, its officers, employees, and agents.
 - b. CONSULTANT's insurance coverage shall be primary insurance as respects AGENCY, its officers, employees, and agents. Any insurance or self-insurance maintained by AGENCY, its officers, employees, and agents shall be excess of CONSULTANT's insurance and shall not contribute with it.
 - c. Any failure to comply with reporting provisions of the policies by CONSULTANT shall not affect coverage provided AGENCY, its officers, employees, and agents.
 - d. Coverage shall state that CONSULTANT's insurance shall apply separately to each insured against whom a claim is made or suit is brought, except with respect to the limits of the insurer's liability.
 - e. Coverage shall contain a waiver of subrogation in favor of the AGENCY, its officers, employees, and agents.
- 2. Workers' Compensation and Employers' Liability

Coverage shall contain waiver of subrogation in favor of the AGENCY, its officers, employees, and agents.

3. All Coverages

Each insurance policy required by this AGREEMENT shall be endorsed to state that coverage shall not be suspended, voided, cancelled, or reduced in limits except after thirty (30) days' prior written notice has been given to AGENCY, except that ten (10) days' prior written notice shall apply in the event of cancellation for nonpayment of premium.

E. Acceptability of Insurers

Insurance is to be placed with insurers with a Best Rating of A VIII or better.

F. Verification of Coverage

CONSULTANT shall furnish AGENCY with certificates of insurance and with original endorsements affecting coverage required by this AGREEMENT. The certificates and endorsements for each insurance policy are to be signed by a person authorized by that insurer to bind coverage on its behalf.

G. Subcontractors

Retroactive Services.

However, in no event shall CONSULTANT be compensated for work performed for AGENCY prior to _____.
